



INVITATION TO BID (IB)

The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

- Name of Project:** Indian Mega Familiarization Tour
- Brief description of the Project:** To introduce destinations, showcase the tourism products, and educate the travel trade and wedding planners on the country's readiness to accommodate these Indian tourists as well as other activities that Indian travelers look for in our destinations.
- Approved Budget for the Contract:** Four Million Fifty Four Thousand Six Hundred Twenty One and 16/100 Philippine Pesos (P 4,054,621.16)
