

**INVITATION TO BID (IB)**

The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

Name of Project: **Production of Promotional Materials for the National Tourism Development Plan (NTDP) 2016-2022 Roll-Out**

Brief description of the Project: Production of promotional materials such as Collared Polo Shirt, Foldable Backpack, Flash drive, Writing Notebook, Ballpen, Lanyard, and Bookmark.

Approved Budget for the Contract: One Million Three Hundred Forty Pesos (PhP1,340,000.00) inclusive of all applicable taxes

Contract Duration: October –November 2017

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding.
