TERMS OF REFERENCE

I. PROJECT

Four City Road Show to India 2017

II. BACKGROUND

The Department of Tourism will be conducting a Four City Road Show to India from October 21 to 28, 2017 (inclusive of travel time). The Four City Road Show will visit Hyderabad, Lucknow, Jaipur, and Chandigarh. The Road Show's main component is the business to business (B2B) travel exchange to be organized in each city. This is expected to increase business connections resulting in the availability of more tour packages to Philippine tourist destinations. The Road Show will also generate participants to future travel trade and corporate fam trips in order for them to learn more and experience our country first hand.

III. PURPOSE/OBJECTIVES

- To sustain interest and further stimulate group travel which has contributed to the continued increase in visitor arrivals from India;
- To ensure availability of tour packages to the Philippines by partnering with tour operators;
- To make available more tour packages to the Philippines in more areas in India through partner tour operators; and
- To make the Philippines as one of their preferred leisure/holiday, MICE, luxury, and wedding destinations.

IV. SCOPE OF WORK/DELIVERABLES

The Philippine Department of Tourism requires the services of a group of four (4) persons who will perform Philippine cultural dances presentation as a group, in pairs and individually during the conduct of the Four City Road Show to India 2017, and create a fun atmosphere to highlight the Philippine brand "It's More Fun in the Philippines" program. They can also perform other genre of dances like modern dances, ballroom, LED poi, international – ASEAN, Polynesian, belly dance, Indian dance).

In exchange of the performance, the DOT will provide for the entertainers' roundtrip international airline tickets, accommodations and transportation while in India, visa processing and fees, travel tax, travel insurance, daily allowance, and terminal fees.

V. PAYMENT PROCEDURE

Following is the payment procedure:

- a. Performance/Production Fee of PHP 110,000.00 inclusive of tax, payment after services is rendered
- b. Daily allowance of \$75 per day per pax to cover meals and other incidental expenses shall be given upon arrival in India
