 Reference: Scope of work/Deliverables:

1. Additional work station for Usec Staff (6 seating capacity)

- a. Supply and Installation of ten (6) seating capacity (3X2 work station)
- b. System furniture 50mm thk 1200mm high sitting privacy panel, perforated panels at exterior lower sides, laminated veneer at interior lower sides, 100% polyolefin fabric with fire retardant treatment at upper parts all sides, metal baseboard / raceway with pre-punched holes
- c. 1200mm width X 600mm depth
- d. Worktops 28mm thk high pressure laminate in wood grain pattern thk work top heatproof scratchproof rubber edging, panel supported, provide grommets
- e. Powder coated metal trims, complete with accessories.

2. Staff Chair/clerical chair, low back (6 sets)

- a. 2-piece moulded Beachwood frame ergonomically designed; original single lever mechanism with tilt and non-tilt function; GAS CYLINDER in pneumatic gas lift mechanism with minimum 50mm dia gas cylinder head for durability
- b. Height adjustment 950 -1045mm:
