



INVITATION TO BID (IB)

The Department of Tourism - Bids and Awards Committee (DOT-BAC), invites PhilGEPS registered suppliers/contractors to bid for the hereunder project:

Name of Project: **Purchase of Motor Vehicles**
Brief description of the Project: To purchase fifteen (15) units of motor vehicles to implement the first year requirement of re-fleeting of DOT's vehicle
Approved Budget for the Contract: Twenty Million Eight Hundred Twenty Two Thousand Philippine Pesos (PhP 20,822,000.00)
Contract Duration: September – October 2017

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.
